## RE: Follow-Up to April 28, 2019 Request of the Board of Directors

Dear Secretary Frazer and Members of the NRA Board of Directors:

I am writing to follow up on the letter I first sent to you all on April 28, 2019, regarding a resolution presented by a member at the Annual Meeting in Indianapolis. The resolution expressed disappointment with the Audit Committee, the Finance Committee, the Executive Committee, and Mr. Wayne LaPierre in light of recent credible allegations of serious financial mismanagement vis-à-vis Ackerman McQueen. It also urged Mr. LaPierre's immediate resignation.

Rather than being voted upon by the members assembled, the resolution was referred to the Board of Directors. In my April 28th letter, I made the following proposal:

When the Board addresses this resolution, I request that any Board member, officer, or staff member who has a personal, financial, or fiduciary interest in, or fidelity to, Ackerman McQueen (or its subsidiary and affiliate companies) — as an employee, contractor, paid consultant, vendor, client, etc. — be required to recuse himself/herself from discussing and voting on this resolution.

To date, only two of the 76 Board members have formally responded to my letter and addressed the specific issue of vote abstentions. I am grateful to those who took the time to respond, as I do understand that your time is valuable. The 300 dues-paying NRA members (so far) who have added their names to my original letter are also valuable. They would appreciate a response from their elected Board Members, as would I.

For your convenience and review, I have enclosed the April 28th letter, along with the appended names of those 300 supporters. Considering the sparse response we have gotten so far, I would humbly add a few more brief inquiries, to which we all hope to receive direct and prompt answers:

- (1) On what specific date will the Board discuss and vote on the referred resolution?
- (2) Will you personally (each individual Board Member) support the call for recusal of any Board Member directly involved with Ackerman McQueen or otherwise implicated in the referred resolution?
- (3) Will the Secretary's Office make available an itemized account of each Board Member's vote on the resolution (a roll-call vote, rather than a vote by acclamation)? I understand that the discussions might be shielded by Executive Session confidentiality, but I am only asking for list of names and raw vote counts yea, nay, abstain, and absent.

(4) The next NRA Board Meeting is scheduled to take place in Anchorage, Alaska – over 4,200 miles from the NRA's headquarters in Fairfax, Virginia. One can only imagine that financing such a distant trip for so many board members, officers, and staff would be far more expensive than hosting the meeting closer to the NRA's base of operations. Given the NRA's own claims of financial hardship and costly impending battles (pleaded as a predicate to recent aggressive fundraising campaigns) and the mounting reports of financial mismanagement and overspending, would the NRA Board consider relocating the next Board meeting to a more cost-effective venue?

That third request is in keeping with the broader theme of avoiding any appearance of impropriety. One of the responses I received to the April 28th letter insisted that recent negative press reports should be "take[n] ... with a grain or two of salt" because they mostly come from "people dedicated to taking down the NRA." If that is true, then the NRA cannot afford (literally or figuratively) to feed that narrative by condoning what opponents will surely spin as an unnecessarily lavish, over-indulgent summer excursion to one of the nation's farthest reaches. Meeting in Anchorage also stifles any effort by most rank-and-file members to exercise their rights under Article III, Section 6(d) of the NRA Bylaws ("All members ... shall have the right to attend all meetings of the Board of Directors, Executive Committee, and standing and special committees of the Association, except during executive sessions thereof").

In my casual discussions with fellow members in Indianapolis, one conversation stood out. It was with a current NRA Board Member. This Board Member expressed modest concern about the recent negative press reports surrounding the NRA Leadership. But the Board Member was also heartened by an overriding impression that the general membership still "loves Wayne LaPierre." I humbly countered that while Mr. LaPierre might enjoy widespread approval from long-serving Board Members, from high-power donors and politicians, and from those who get invited to exclusive dinners and receptions, that is not the overall sentiment among the broader membership. Even a cursory perusal of social media platforms easily confirms that fact. This Board Member seemed genuinely surprised to hear me say that. The whole encounter made me wonder if perhaps some of the NRA Leadership may not fully appreciate the seriousness of the growing unrest and mistrust that now threatens the NRA from the inside. If we do not act swiftly to restore trust and confidence among the members, Michael Bloomberg and Letitia James will be the least of our problems.

Also enclosed is a sampling of comments that people have sent along with their requests to be added to my April 28th letter. I invite you all to browse those comments. I hope they offer some insight as to how the members feel about recent events. I also hope they will inspire each Board Member to provide a formal response to these concerns rather than assuming they will simply fade away.

Regarding Referred Resolution from the 2019 NRAAM

Dear Secretary Frazer and Members of the NRA Board of Directors:

My name is Tiffany Johnson. I am a Benefactor Life Member of the National Rifle Association. I'm an NRA Training Counselor, a Regional Counselor for the NRA's Refuse to Be a Victim® program, and an NRA Chief Range Safety Officer. I teach NRA firearms safety classes to the public several times a month. I'm also a lawyer and a legal studies instructor at my local university.

I attended the NRA Annual Meeting of Members on Saturday morning, and I am writing about a contentious resolution that came to the floor. The resolution decried recent reports of fiscal mismanagement centered around one of the NRA's primary vendors, Ackerman McQueen. Among other things, the resolution called for the resignation of members of the Audit Committee as well as the NRA's Executive Vice President, Mr. Wayne LaPierre. In light of the pending litigation between Ackerman McQueen and the NRA, Secretary Frazer successfully moved that the resolution be referred to the Board of Directors for consideration in consultation with legal counsel.

As a practicing attorney, I fully understand the NRA's interest in limiting public discussion of sensitive matters that are currently being litigated. I agree that the Association is best served by addressing the resolution internally rather than in the public sphere. However, I also understand the arguments raised against referring the motion to the Board. The resolution cited allegations of financial misconduct, self-dealing, and conflicts of interest within the Board of Directors, the Audit Committee, and other parts of the NRA's leadership team, based on their alleged mishandling of vendor contracts and other business relationships with Ackerman McQueen. In other words, referring the resolution to the Board would be, in effect, asking the Board to adjudicate allegations against itself.

I want the National Rifle Association to succeed. At Saturday morning's meeting, Mr. LaPierre himself warned of the mounting existential threats we now face, both in the courtroom and in the court of public opinion. Given the intensified scrutiny facing the Association right now, I fear that yet another maneuver of impropriety (whether real or perceived) could be a proverbial death knell. It would serve as perfect fodder for the media to publish yet another scathing exposé that paints the NRA as roiled in unsavory scandal. It would also incite even more resentment from within the organization and sow more division among our ranks. Although Mr. Frazer's motion to refer the resolution did ultimately succeed, the fierce opposition voiced by many in attendance shows that members want this issue to be addressed in a more transparent fashion.

I have a humble suggestion to help avoid public airing of private business while also quelling further cries of impropriety. When the Board addresses this resolution, I request that any Board member, officer, or staff member who has a personal, financial, or fiduciary interest in, or fidelity to, Ackerman McQueen (or its subsidiary and affiliate companies) — as an employee, contractor, paid consultant, vendor, client, etc. — be required to recuse himself/herself from discussing and voting on this resolution. That way, regardless of how the Board ultimately disposes of the resolution, at least the result will be less vulnerable to accusations of ethically dubious entanglements.

I ask that you please present this letter to the members of the Board of Directors before they consider the resolution. I write this letter as a friend to the NRA and a genuine supporter. I hope it is received in the manner it was intended, and I thank you in advance for your consideration. I am the only signatory to this letter, but I have also included the names of fellow NRA members who support my request. We have placed our trust in you as the elected leaders of this Association, and we all send our best wishes for a productive Board meeting on Monday.
